



New Programs to Meet Increasing Needs

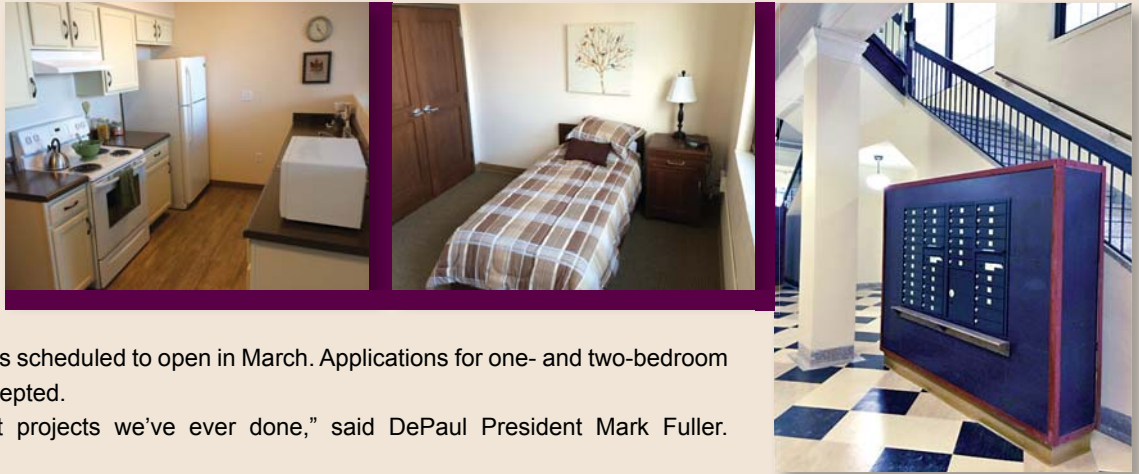
DePaul is increasing its ability to serve even more people in need with new projects in the works for affordable housing and mental health.

In Buffalo, New York, the Riverside Apartments, a newly-remodeled program for income-eligible tenants

located at 238 Ontario Street, is scheduled to open in March. Applications for one- and two-bedroom apartments are now being accepted.

"This is one of the best projects we've ever done," said DePaul President Mark Fuller. "It's absolutely stunning."

Elements of the original architecture and historical features have been retained in the repurposing of the former Public School 60, later known as Riverside Academy, which is over 100 years old.

Rochester View Apartments



A spring groundbreaking is planned for the Rochester View Apartments, featuring 61 one- and two-bedroom apartments for income-eligible tenants. The program will offer enhanced supports to accommodate tenants who may be deaf, hard of hearing or those using ASL, and will be located in Henrietta, New York.

"We're excited that affordable housing for persons who are deaf will be a reality in Rochester," said Gillian Conde, Vice President of DePaul Properties, Inc.

In Rochester's Susan B. Anthony Preservation District, construction continues on the 71-unit Carriage Factory Apartments which have an anticipated September 2014 completion. Fuller said the building required significantly more environmental remediation than was initially anticipated.

"The neighborhood is very excited to see the building, which had been vacant for nearly 25 years, being rejuvenated," Conde said. "It's been an old eyesore for the neighborhood. Even having the building lit has made a huge difference for area residents. This project is changing the dynamics of the entire neighborhood."

“If it’s meant to be, I’ll publish a book someday,” he said. “It’s been the toughest battle in the world, but where there is hope, the dream lives on.”

Chris graduated magna cum laude with a degree in English from SUNY Brockport, ranking eighth in his class. He was in his mid-20s and teaching abroad in Thailand when he had a nervous breakdown. Diagnosed with bipolar disorder, Chris, 69, has held more than 20 different jobs over the years. Diagnosed with kidney disease eight years ago, he now requires dialysis three times a week.

For Chris, writing is therapeutic. His inspiration comes from

his education, his family and his friends.

“I like to write about insights, nuances and subtleties of life that people might not have thought about,” he said.

A DePaul client for 18 years, Chris said he’s been making a lot of progress with the help of DePaul and his Supported Housing Specialist Christina Mastin. Chris is a creative and bright individual with a great appreciation for life, said Mastin.

“Chris has come a long way on the road to recovery and no matter how difficult his setbacks have been, Chris has shown me there is nothing he can’t learn from,” she said. “His determination to fulfill his dream of becoming a published writer is so inspiring.”

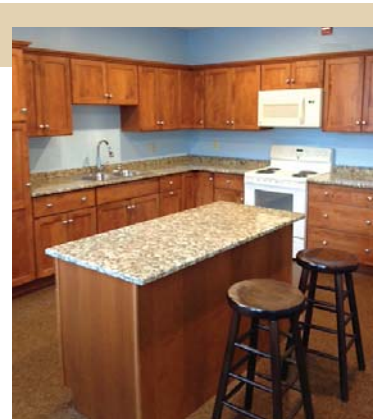
Kensington and Seneca Square Renovations

Kensington Square and Seneca Square, two of DePaul’s Single Room Occupancy (SRO) programs in Buffalo, New York, are the latest facilities to receive improvements.

“DePaul is committed to providing welcoming, homelike living environments for those we serve,” said President Mark Fuller. “Pleasant surroundings are integral to delivering the highest quality care and are conducive to recovery.”

Improvements include a new rustic, cozy fireplace welcoming residents, staff and visitors to both Kensington Square and Seneca Square’s lobbies. Seneca Square has added unique artwork featuring historical photos of Buffalo landmarks, all taken by residents.

“The most significant upgrade at Seneca Square was the conversion of a former smoking room into the new training kitchen which will assist residents as they ultimately transition into independent living,” said Fuller.

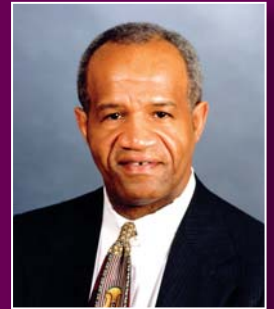
