Supportive services can also assist in linking people with educational and skill building services such as money management and meal preparation.



Our Apartments

DePaul buildings feature a mix of studio, oneor two-bedroom apartments and townhomes, depending on the site. Apartments have a fully equipped kitchen with a range, refrigerator and microwave and a wall-mounted flat screen TV including local channels, basic cable service or cable hook-ups. Units have either in-unit storage or secured storage elsewhere in the building depending on the location.

Heat, air conditioning, hot water and electric are included in the rent and on-site laundry facilities are available at no cost to the tenant. There is also off-street parking. Tenants typically have access to a community room, lounges and a computer lab. Complimentary Wi-Fi is available in common areas in most buildings. The buildings are 100 percent smoke free. Designated smoking areas are provided outdoors.

Each building is centrally located to many local amenities that tenants may need such as grocery shopping, schools, places of worship, medical care, banks, libraries, government agencies and general shopping. On-site services are available for a defined number of tenants at each site. Housing Specialists at the sites teach skills and assist tenants in linking to community services.

There are normally ADA and Hearing and Visually Accessible (HVA) units in each site. Rents vary by site and by unit type and can be obtained by phone, email or by visiting the website. A security deposit equal to one month's rent is required at the lease signing and the applicant must meet the eligibility requirements of the Low-Income Housing Tax Credit Program. Income and occupancy requirements apply.


