


Our Mission





DePaul Mental Health Residential Programs

Since 1958, DePaul has been dedicated to providing services, support and hope to persons with a mental health diagnosis. Housing is a recognized cornerstone for recovery, offering stability, access to resources and a foundation for independence and success. New York State is home to a variety of DePaul housing options with varying degrees of independence including licensed congregate treatment sites, apartment treatment programs, community residence - single room occupancy programs, supportive housing and transitional housing.

A person's mental health is affected by many factors including the ongoing COVID-19 pandemic. People experienced increased symptoms of anxiety and depression along with changed sleep and eating habits which had the potential to result in more worry, stress and the worsening of chronic conditions. DePaul recognized the implications for those in our care and worked diligently to provide additional supports to help mitigate the effects for people in our programs. The level of stability experienced along with the assurance of safe housing, food security, and linkages to needed services proved invaluable.

Additional accomplishments achieved in 2022 included the following.

Approximately \$2 million in renovations were completed at **Edgerton Square** in Rochester, DePaul's first Community Residence – Single Room Occupancy Program which opened in 2000. They included interior and exterior improvements such as new roofing, a new generator, repaving, new flooring, paint, a full fire alarm replacement and lighting and mechanical upgrades.



New York State Assemblymember

Mike, a resident of the **Batavia Apartment Treatment Program**, shared his story and information about **Forgotten Ones**, his peer-support network for those struggling with addiction, mental health, and/or coping with daily life. Mike's story was featured in The Daily News and The Batavian.

Crisis Housing apartments were increased to 23 units scattered throughout Genesee, Livingston, Monroe, Orleans, Wayne and Wyoming counties. The counties consider these apartments a valuable resource for mental health recipients who are in dire need of housing.

The Rutherford Place Licensed Congregate Treatment Program in Depew received a new roof, siding, gutters and porch.

DePaul's three staff and client support teams — Reintegration Support, the Recreation Program, and Care Management — served over 400 clients in 2022. Services ranged from providing numerous self-help and support groups to recreational activities and linkages to other critical support services in the community. These services are vital to DePaul's clients and even more so during the pandemic.

DePaul's Care Management Program served nearly 200 clients who experienced a return to community-based activities such as volunteering, educational programs, and mental health rehabilitative programs.







A three-year certification was received for all of DePaul's licensed residential programs in Buffalo and surrounding regions from the New York State Office of Mental Health.

DePaul supported staff education and development throughout 2022, hosting Bachelor's- and Master's- level interns, two of whom came to work for the Care Management Program after completing their internships. The program also received designation as a Specialty Mental Health Care Management Agency after achieving performance scores of 83-95 percent on state-determined metrics. This allows DePaul to continue providing Health Home Plus services, which give increased levels of support to higher-needs individuals.

Parkside, a DePaul Community
Residence – Single Room Occupancy
(CR-SRO) Program in East Rochester
and Riverside, an Apartment Treatment
Program in Buffalo, continued providing
donated clothing items to DePaul
residents through REFRESH clothing
boutiques. Clothing items are donated
and cleaned by local area dry cleaners
before being made available to all DePaul
residents at no cost.

DePaul Senior Living Communities

As part of our mission-driven commitment to serving the elderly, DePaul's five senior living communities in Western New York provide assisted living, memory care and independent living options where residents enjoy the comforts of home, a commitment to enhancing quality of life, and personal care services in supportive environments that foster community while promoting independence.

In 2022, **Westwood Commons**, a DePaul Senior Living Community in North Chili underwent renovations including fresh paint, a new beauty salon, new furniture in the common areas, lounges and activity room, boiler/HVAC upgrades, a new dishwasher, new fire panel and system upgrades, along with updated LED lighting in hallways and common areas.



The dining room at **Heritage Manor of Lockport**, a DePaul Senior Living Community in Lockport was updated with new flooring, lighting and furniture.





Caregivers at DePaul's senior living communities recognize that activities and socialization are truly vital ingredients for resident happiness and satisfaction. Creative activities included themed food stations including omelet stations and a "pasta-bilities" bar, fundraisers for the Walk to End Alzheimer's including hot dog and sundae sales, entertainment from musicians and magicians, spirit weeks with staff and residents sporting wacky socks, colorful wigs and homemade tie-dye shirts, special celebrations including Pride Month and Juneteenth, photography club and cooking club, trips to the aquarium and local museums, virtual hot air balloon rides to the Bahamas and Florida Keys, standing on top of the Eiffel Tower, camping trips and visits to family homesteads using Rendever virtual reality headsets, crafts including papiermâché pumpkins, pressed flower glass jars and guided paintings and hobbies including playing the keyboard, writing poems, coloring and cross stitch.



DePaul had the pleasure of serving ten centenarians in 2022, the oldest of whom turned 107.

In 2022, DePaul seniors believed in making a difference and giving back!

Heritage Manor of Lockport hosted a food drive with donations going to the Resource Council of WNY to support Buffalo families affected by the Tops Supermarket hate crime. The community also hosted a pet food drive to benefit Diamonds in the Ruff Animal Rescue.



While the Niagara SPCA was working on finding Lloyd a foster home, he enjoyed a series of "bucket list" adventures throughout Niagara County - "The Adventures of Lloyd!"







DePaul Affordable Housing Programs

Quality, stable, affordable housing – it's a critical social determinant of health. It's a fundamental human need that helps not only individuals but communities. DePaul develops and operates attractive, affordable housing solutions in urban, suburban and rural settings, along with supportive services that help people live more stable, productive lives. Every day, we see community relationships thrive and individuals triumph, taking pride in their new homes.

DePaul recognizes that many societal inequities exist when it comes to accessing safe, affordable housing, adequate food, healthcare, education and needed supports. DePaul is determined to evolve with the ever-changing world providing additional resources and services that meet growing needs and foster independence.

Our progress was seen in the following accomplishments.

In September 2022, DePaul completed construction and opened the **Lock 7 Apartments** in Oswego containing 80 units for income-eligible tenants with 40 Empire State Supported Housing Initiative (ESSHI) units. This includes providing on-site services for 40 units, with housing specialists that teach skills and assist tenants in linking to community services. Located on the Oswego Canal, the Lock 7 Apartments were constructed on the former site of the Breneman Company, a fabric and window shade factory.



DePaul completed construction on and fully occupied the final building of the **Apple Blossom Apartments** in Cheektowaga which have a total of 110 units for incomeeligible tenants. The original Apple Blossom apartment building was renovated to add 15 one-bedroom units to the already existing 15 two-bedroom units. New construction included two new buildings each containing 40 units. The project has 15 supportive ESSHI units. The three buildings are named for apples grown in New York State: Gala, Empire and Cortland.

The **Boxcar Apartments**, a 40-unit project for income-eligible tenants in Albion were fully occupied in 2022. The community contains 20 ESSHI units providing on-site housing specialist support services which include linkages to community services that assist persons in living as independently as possible.

Construction continued on the **Batavia Apartments** in Batavia, adding 20 supportive ESSHI units for income-eligible tenants to the existing 42 units. Completion is anticipated in the summer of 2023.



Construction neared completion on the **Veddersburg Apartments** in Amsterdam. Named for the original settler of that region, Albert Vedder, the project contains 62 units for income-eligible tenants with 31 supportive ESSHI units. It is expected to open in Spring 2023.

In December 2022, DePaul started construction on **Pan-American Square** on Delaware Avenue in Buffalo, a relocation of beds from McKinley Square, a DePaul CR-SRO. Plans include increased energy efficiency design features for 150 units for income-eligible tenants that include 20 supportive ESSHI units and 80 CR-SRO units.

Pan-American Square is PHIUS+ 2018 & Source Zero Pre-Certified. PHIUS (Passive Housing Institute US, Inc.) is a non-profit 501(c)(3) organization committed to decarbonizing the built environment by designing high-performance passive building the mainstream market standard. DePaul is also pursuing a number of certifications including: Energy Star Multifamily New Construction Program, DOE Net Zero Energy Ready Homes and EPA Indoor AirPLUS.



Construction neared completion on the Holland Circle Apartments in Amsterdam. The project contains 48 units for income-eligible tenants with 27 licensed units to be operated by the Mental Health Association in Fulton & Montgomery Counties. Anticipated to open in the summer of 2023, the site includes five buildings: a one-story office/community building and four twelve-unit residential buildings.



DePaul began construction on the **Port Byron Apartments** in Port Byron which will contain 69 units for incomeeligible tenants with 30 supportive ESSHI units. Once constructed, the apartments will replace the current 39-unit Church Street Apartments.

Initial challenges and improvements included spending two weeks cleaning up garbage and unsanitary conditions in the hallways and hiring regular housekeeping services, removing five dumpsters full of garbage, establishing a pet area, thoroughly cleaning the community room and adding new tables, chairs and décor, and adding onsite security. A welcome picnic was hosted for residents and DePaul Properties staff are on site every day. The project is anticipated to be completed by the end of 2023.

DePaul Affordable Housing Programs (continued)



Plans continued for the **True North Apartments** in Rochester that would contain 70 units for income-eligible tenants with 35 supportive ESSHI units.

Plans continued for the **Granary Apartments**, an 80-unit project in Sanborn containing 25 supportive ESSHI units and 20 Community Residence/Apartment Treatment Program units for income-eligible tenants. This project involves collaboration with Community Missions, Inc.



Plans continued for the **Mosaic Apartments** in Schenectady containing 60 units for income-eligible tenants with 30 supportive ESSHI units.



Plans continued for the **Dansville Apartments** at two sites in Dansville. The King's Daughters Apartments will have 12 total units and the Balloon Lofts will have 48 total units. Of the 60 units, 30 will provide supportive ESSHI services.

Future and potential New York projects include sites in Albany, Fort Plain, Olean, Utica, and Watertown, and the McKinley Square redevelopment.

WorkGuide, a DePaul Vocational Program

DePaul WorkGuide provides essential linkages for persons with a disability seeking employment. The program matches consumers' talents and abilities with positions at well over 100 employers in Monroe County. Vocational and supported employment guide people in successfully entering or reentering the workforce, providing supports that assist in overcoming obstacles, and eradicating stereotypes that can surround employing persons with a disability. Workplace accommodations are cost-effective and easy to implement, providing employment and independence that benefit the consumer, the employer and the community.



The following outcomes were achieved in 2022.

- WorkGuide provided services to 459 people across all employment programs.
- 231 people participated in placement services with the goal of achieving and maintaining competitive employment.
- 182 participants were employed.
- 87 people were placed in new jobs and 36 people in new internships.
- 119 vocational assessments were completed.
- 33 people who received Intensive Job Coaching support were stabilized in their jobs and successfully transitioned into extended services.
- 56 people reached the 90-days-employed milestone in their new jobs.
- 91 people enrolled in Work Readiness and Self-Advocacy classes for adults and students.
- 19 people graduated from Supported Employment Program by achieving independence in maintaining employment.

Ticket to Work (TTW) Program

- 15 clients were employed 30 hours or more and are on track to become fully self-sufficient.
- Two more candidates in the TTW Program achieved self-sufficiency by completely transitioning off SSI or SSDI entitlements and graduating from the TTW Program.

WorkGuide placements included a wide-assortment of jobs, ranging from entry-level positions in retail and food service to careers requiring degrees such as finance, information technology, and engineering. They included placements such as Assistant Court Analyst for Monroe County, Engineer at The DDS Companies, Grant Management Specialist at the Environmental Protection Agency, Graphic Designer, Lab Tech at Evolve Solutions, Nutritionist at RIT/NTID and Web Accessibility Coordinator at SUNY Brockport. Manufacturing and retail jobs were also on the rise and candidates were placed at HomeSense, Restaurant Depot, Staples, LeanLife, Sherwin-Williams and Turner Bellows, Inc.

In 2022, WorkGuide moved to a new building at 1000 University Avenue in Rochester. Program clients and staff also celebrated the immense difference made by the program during National Disability Employment Awareness Month (NDEAM)!




DePaul Recreation

Activity, whether it be creative, social or physical, for those with mental health diagnoses, can play a vital role in recovery. DePaul has always recognized the key importance of recreation and the resulting health benefits. Though the COVID-19 pandemic reduced options due to maintaining recommended social distancing and hygiene protocols, DePaul's Recreation Program inventively provided this needed resource, offering a critical outlet for coping with stress, reducing boredom and refocusing on positive experiences. In 2022, DePaul's Recreation Program was pleased to welcome residents back for programs at the Rochester Administration building in April.

There were outings to Charlotte Beach, the Fairport Canal, Genesee Country Village & Museum, various beaches and parks, Lollypop Farm, Rochester Red Wings and Rochester Americans games, Seabreeze Amusement Park and the Seneca Park Zoo. Other events included the 17th Annual Canal Clean Sweep, the annual Staff vs. Resident softball game, the Buffalo Bills training camp, a myriad of festivals and parades as well as trips to the Rochester Public Market and the Great New York State Fair. There were crafts aplenty including DIY kites, limerick writing, sand art, Valentine gnomes, vision boards and cards for all occasions. Contests included basketball hotshot, bocce, corn hole, euchre, hole-in-one, trivia, pool and name that tune. Each month, the Recreation Department also personally delivers each resident a birthday card and special treat/goodie bag with an in-person 'Happy Birthday' wish!

All of Recreation's efforts provide a way to stay connected and engaged, ultimately leading to improved wellness.



Hopelink at Shelter Cove

Hopelink is short-stay residence in Churchville in which individuals who are hospitalized have exclusive access to a unique residential alternative upon discharge from the medical hospital. It is a partnership between DePaul Community Services and UR Medicine/Strong Memorial Hospital.

Fifty-one clients were served in 2022 who were discharged from UR Medicine/Strong Memorial Hospital.

As this care alternative evolves, increased levels of medical acuity are experienced by those referred, including paralysis, severe complications of end-stage cancer, and numerous people with significant cognition issues. In addition, the number of people who come to Hopelink with medical issues directly related to an ongoing substance use problem is very significant.




National Council on Alcoholism and Drug Dependence - Rochester Area (NCADD-RA)

The National Council on Alcoholism and Drug Dependence - Rochester Area works to reduce the impact of alcohol, other drugs and problem gambling. Programs include the Addictions Counselor Credential Training (ACCT) Program, community education for adults and youth, the Finger Lakes Addiction Resource Center, the Finger Lakes Prevention Resource Center, Hispanic Prevention Education Program, Professional Continuing Education and the Total Approach Family Program. The Council, which celebrated 76 years of service to the community in 2022, provides education, information, support and referral services to individuals, families and the community.



NCADD-RA continued to offer education and community presentations both virtually and in person and received a surge of health/resource fair requests in 2022. Community education requests have returned to pre-COVID levels, providing education both virtually and in-person.



The Finger Lakes Addiction
Resource Center completed biannual revision of multiple referral
directories, initiated a recovery
engagement project at summer
health fairs and continued
virtual meetings and community
professional development.

The Finger Lakes Prevention Resource Center provided technical assistance and training throughout the 12-county Finger Lakes region to over 20 community coalitions.

The foster parent classes increased attendance due to Zoom delivery.

The youth evidenced-based programming, Too Good for Drugs, targeted for school district partners, reached multiple schools/classrooms and grade levels.

NCADD-RA received an extension on two State Strategic Opioid Response (SOR) grants that originally ended in September 2022.

The program received Substance Abuse Prevention and Treatment (SAPT) grants for infrastructure, workforce and stabilization. These dollars allow for an increased media presence and funds to purchase evidence-based curricula and staff training.






COVID-19 and its Impact on DePaul

The COVID-19 pandemic continued to be unprecedented in its scope and impact with conditions fluctuating throughout the year. DePaul staff rose to the occasion in their comprehensive and proactive responses. Our dedicated team was able to persevere through many challenges, continuing to provide the highest quality care throughout and for that we are immeasurably grateful.

The outpouring of support and donations from families and community members continued. We are beyond grateful for the endless support that brightened each day for residents and staff!





Representative Payee Program

DePaul is certified to serve as a representative payee for interested individuals residing in Erie, Monroe, Ontario and Wayne counties. When someone requires assistance in managing their money, DePaul can be appointed to serve as a representative payee ensuring that income is used for the personal care and well-being of the individual DePaul is representing. DePaul served over 1,100 people in 2022 and relocated the Monroe County program site to a new location.

Historic Winter Storm

The 2022 holiday season brought Buffalo a historic winter storm that devastated the region. Our truly heroic DePaul team ensured the seamless delivery of the highest quality care, demonstrating their dedication to the people we serve and to their fellow staff members going above and beyond.

The storm was paralyzing with whiteout conditions, feet of mounting snow, dangerous winds and frigid temperatures. In many instances staff members were unable to come in for their shift, thus those already on site remained for two to three days over the holiday, doing everything they could to bring care, services and comfort to our residents. Many sites lost power but generators were functioning, however at Seneca Square in Buffalo, the site not only lost power but the generator stopped functioning due to the intense cold and snow. Everyone gave of themselves to support each other and ensure proper care at such a difficult time.

The sites most impacted included the Apple Blossom Apartments, Ebenezer Square Apartments, Kensington Square, McKinley Square, Packet Boat Landing Apartments, Riverside Apartments, Rutherford Place Licensed Congregate Treatment Site, Seneca Square and the DePaul Senior Living Communities Glenwell, Heritage Manor of Lockport and Wheatfield Commons.

There were so many stories of teamwork with staff members snow blowing and shoveling throughout the ordeal, mopping floors, people cooking, cleaning and supporting each other. They truly demonstrated why DePaul is recognized for our culture of caring!






Making a Difference at the Clinton Avenue Apartments

The ESL Charitable Foundation awarded WorkGuide with a \$26,863 grant to provide operational funding to enhance the Supported Employment Program. WorkGuide has decades of experience providing vocational support to individuals with mental, developmental or physical disabilities seeking assistance with gainful employment in Monroe County.

The Mother Cabrini Health Foundation awarded DePaul a \$90,500 grant which was used to support the ongoing cost of technology engagement programs at DePaul's senior living communities. Funds are being used to maintain the costs associated with Eversound wireless headphones, Rendever virtual reality headsets and iN2L, a content-driven engagement technology.
